



## AAT Professional Diploma in Accounting - BU401

The AAT Level 4 Diploma in Professional Accounting is the third and final stage of the full AAT qualification.

It is a professional course which will give you the skills to excel at a wide range of accounting and finance jobs.

### COURSE DETAILS

Students will build on the management accounting knowledge that they have acquired during studies at Levels 2 and 3, whilst acquiring new knowledge and skills in the areas of taxation and credit management. There are three mandatory units:

- Applied Management Accounting
- Drafting and Interpreting Financial Statements
- Internal Accounting Systems and Controls

There are also two optional units that we teach:

- Personal Tax
- Credit & Debt Management

All five units are required in order to pass the qualification.

This qualification is equivalent standard to a foundation degree.

## ENTRY GUIDELINES

Students are required to have completed the Level 3 Diploma in Accounting before commencing this course. You will also be required to attend an interview prior to enrolment.

Initial unit exams are included in the course fees. Exam resits are an extra cost, which at Level 4 is £63 for all exams. There is also an extra cost for course textbooks, which is approximately £60.
